What Are Subscription Legal Services?

Simply put, it means our experienced Solicitors, Barristers and overseas Attorneys will undertake all contract, commercial or employment work you require (in as many jurisdictions as you need), at a set monthly fee. This would be on a simple twelve month contract. The fee is guaranteed not to increase, even if the monthly volumes of workload fluctuate. The ever present business issues of availability due to size of a team, illness and holidays are irrelevant, as we always have experts available every day to meet your business needs.

What Makes Subscription Legal Services So Cost Effective?

Our distributed labour model, lack of costly town centre/city premises, and use of advanced cloud-based technology enables us to operate on a low overhead model. The savings made are passed to our valued clients.

What Subscription Legal Services Are Not:

Our Subscription Service is not what is commonly known as a “Retainer Service”. If you agree to a Retainer Service you pay for a set number of hours at a discounted hourly rate. You are then charged at the full rate after you have used all your agreed hours. This can result in additional, unbudgeted expenses.

What is the Cost?

Our subscription service in the UK, and within various other overseas jurisdictions, should cost less than employing a contracts manager or full-time, in-house legal counsel (depending on the complexity of work); and substantially less than using external legal counsel.

Additionally, clients of our subscription service also benefit from a guaranteed turnaround of workload, typically within 48 hours, as standard.

We also guarantee that all your work will be carried out by our qualified Solicitors, Barristers and overseas Attorneys each of whom are no less than 5 years qualified within their respective industry specialisms. We never use paralegals, trainees or other junior associates.

We estimate cost based on the complexity and value of work load and set the monthly fee for a three month trial period, after which, in consultation with you, we set the fee for a full 12 month period.

What About Other Types of Legal Services?

If you utilise our subscription service, all other business law matters undertaken in the UK, with the exception of litigation, are charged at a flat-rate of £135.00 (excl VAT) per hour.

Litigation, which is a regulated service in the UK, is charged to our member clients at a discounted flat-rate of £212.50 (excl VAT) per hour. This work will be conducted through our SRA registered practice 360 Law Services by an experienced litigator.

Overseas jurisdiction costs may be slightly higher.
